### Northern Nevada Ask A Lawyer Sessions

Nevada Legal Services (NLS) is a non-profit organization providing free legal services to low income Nevadans in all counties. We provide legal assistance to eligible clients with legal matters, such as bankruptcy, unemployment, housing, public benefits, family law, small claims, debt collection, simple estate planning and criminal records sealing (Nevada Only). We also provide community clinics, classes, outreaches, and Ask A Lawyer events throughout Nevada.

Volunteer attorneys who sign up and assist with ask a lawyer sessions are eligible for Pro Bono CLE credit. Attorneys will receive 1 CLE credit for every 3 hours volunteered with a max of 4 CLE credits per year.

**Attorneys who volunteer for 1 hour a month will receive all 4 Pro Bono CLE credits at the end of the year.**
